
SCAG will conduct an assessment to improve the accessibility of *Go Human* resources:

# 2025 Safety Strategies: Community-Led Messaging & Land Use Integration

- SCAG will conduct research to expand its reach and impact in two areas:
  - Community-led Messaging: research on grassroots strategies and best practices to distribute traffic safety messages via local partners.
  - Land Use Integration: research to identify land use strategies and resulting built environment conditions to increase traffic safety.

# SCAG 2025 Regional Active Transportation Program

### 2025 ATP (Cycle 7)

Programs four years of funds: FY25/26 to FY28/29

- Approximately \$169M funding statewide
  - 50% Statewide
  - 10% to Small Urban & Rural
  - 40% to ten largest Metropolitan Planning Organizations with 200,000+ population
- SCAG's regional share is approximately \$35M

### 2025 ATP (Cycle 7): Statewide Component

- 277 project applications requesting \$2.5 billion
   114 applications from SCAG region (\$1 billion)
- 9 projects funded through Statewide Component (\$84 million)
   3 projects from SCAG region (\$36 million)

### 2025 ATP (Cycle 7): Regional ATP

- Regional ATP developed with unfunded Statewide ATP applications and regional supplemental call for projects:
  - 111 applications from Statewide ATP
  - 29 applications from 2024 Sustainable Communities Program (SCP)
     Active Transportation and Safety call
- Regional ATP funding allocated to each county using population-based funding targets.

### 2025 ATP (Cycle 7): Regional ATP

### SCAG 2025 Regional ATP:

- o 15 projects (\$35 million)
- 113 contingency projects (\$972 million)

A small percentage of regional funds are set aside for SCAG staff to support project implementation, particularly projects receiving technical assistance through the 2024 SCP Active Transportation and Safety call.

### Quick-Builds: Implement, Engage, Adjust

- Implement: Quick-builds allow communities to respond to a safety need through surface-level treatments.
- **Engage**: Gather feedback to refine concepts.
- **Adjust**: Modify or remove quickbuild elements based on assessment.





### Caltrans Main Streets Guide

- Caltrans updated <u>Main Street, California</u> guide in October 2023.
- "A California State highway main street serves as a community street that provides access to local destinations along the street."



### Caltrans Main Streets Guide

- Five Guiding Principles:
  - Champion people-centered main streets.
  - Improve safety and public health.
  - Elevate equity and livability.
  - Advance sustainability and climate action.
  - Strengthen partnerships and engagement.
- Guide covers site analysis, community engagement, and design elements.



### Sustainable Transportation Planning Grant

- SCAG received a FY23/24 <u>Caltrans Sustainable</u>
   Transportation Planning Grant
  - Strategic Partnerships category
- Developed *Planning for Main Streets* project in partnership with Caltrans Districts 7, 8, 11, and 12 and local jurisdictions along proposed main street corridors.

### Planning for Main Streets: Study Corridors

#### The study corridors reflect:

- Geographic equity
- Mix of urban and suburban contexts
- Opportunities for multi-jurisdictional partnerships and collaboration
- Active transportation and safety priorities (high injury network, Caltrans ATP)

### Planning for Main Streets: Scope of Work

- Understand Existing Conditions
  - Review of plans, programs, and policies
  - Analyze mode share, existing infrastructure, land uses, collision history
- Collaborate with Communities to Identify Priorities
  - Community Advisory Committees
  - Technical Advisory Committees
  - Walk audits and surveys
  - Workshops
  - Web page updates and presentations



### Planning for Main Streets: Scope of Work

- Develop project recommendations
  - Informed by existing conditions, community input, and best practices/guides
  - Conceptual designs that include feasibility/implementation considerations and intended to be incorporated into work plans and/or grant applications
- Summarize process, findings, and recommendations in a report
  - Supports project implementation by identifying opportunities for further study/design and serves as documentation for work plans and/or grant applications

### Schedule

- November 2024: SCAG/Caltrans grant agreement
- January to June 2025: Consultant procurement
- June 2025: Project kick off
- June 2025 to June 2027: Project development
- June 2027: Project wrap up, transition to identifying opportunities for implementation
