CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Honorable Bill Jahn called the meeting to order at 8:30 a.m. and asked Councilmember Jan Harnik, RCTC, to lead the Pledge of Allegiance.

In conjunction with SCAG's Annual Economic Summit, President Jahn welcomed and introduced the Honorable Toni G. Atkins, President pro Tempore, California State Senate.

Senator Atkins thanked the members for the invitation to speak before the EAC. She praised President Jahn's knowledge and background in housing. Senator Atkins remarked that since the State had made progress in transportation in terms of funding, she emphasized focusing more on housing as there is no easy solution to face the challenges in building housing for the state, the cities and our communities. She also remarked that funding is not the only solution but it is also about regulation and zoning. Senator Atkins articulated her commitment in partnering with SCAG and other agencies to resolve these issues and emphasized the need for collaboration. In closing, Senator Atkins expressed appreciation for SCAG for bringing together business, labor and local governments in working on these issues.

CFO MONTHLY REPORT

Basil Panas, Chief Financial Officer, provided an update regarding the Caltrans audit and the independent external audit. Mr. Panas also reported that 72% of SCAG's membership dues have been collected.

Councilmember Jan Harnik, RCTC, asked a question regarding the two (2) cities in the SCAG region who are not members of SCAG. Mr. Panas responded the cities are Rancho Santa Margarita and Orange.

PRESIDENT'S REPORT

President Jahn announced that he is seeking members to serve on the 2019-20 Bylaws and Resolutions Committee. If interested, he asked the members to contact staff.

President Jahn also announced that he is reappointing the members of the Nominating Committee who were appointed last February. These are: Chair is Immediate Past President Alan Wapner; Los Angeles County Representative Margaret Finlay; Orange County Representative Peggy Huang; San Bernardino County Representative Frank Navarro; Riverside County Representative Ben Benoit; Ventura County Representative Carmen Ramirez; and Imperial County Representative is Supervisor Luis Plancarte.

Finally, President Jahn announced he is seeking members for the General Assembly Host Committee and to notify staff if interested in serving on the committee.

EXECUTIVE DIRECTOR'S REPORT

Executive Director Kome Ajise expressed appreciation for the thoughtful discussions regarding Connect SoCal that took place at the November 7 meeting. A list of elected official briefings have been scheduled throughout the SCAG region and stated that either he or Darin Chidsey, Chief Operating Officer; or Sarah Jepson, Director of Planning, will be presenting in those briefings. To maximize public input, Mr. Ajise stated the Public Hearings have also been scheduled and also reported that the programmatic EIR (PEIR), which accompanies the RTP, is scheduled for a 45-day public review.

Mr. Ajise announced that Sarah Jepson has been appointed as Director of Planning. Ms. Jepson made remarks and expressed appreciation for the opportunity and provided background information regarding her experience. On behalf of the EAC, President Jahn congratulated Ms. Jepson on her new role at SCAG.
