CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Chair Plancarte called the meeting to order at 10:06 a.m. and Policy Committee member Patricia Lock Dawson, Riverside, District 68, led the Pledge of Allegiance. Staff confirmed a quorum was present.

PUBLIC COMMENT PERIOD

Chair Plancarte opened the public comment period and provided detailed instructions on how to provide public comments. He noted that this was the time for members of the public to offer comment for matters that are within SCAG's jurisdiction but are not listed on the agenda.

SCAG staff acknowledged there were no public comments received before the 5:00 p.m. deadline on September 4, 2024.

Seeing no public comment, Chair Plancarte closed the public comment period for matters not listed on the agenda.

INFORMATION ITEMS

4. Climate Pollution Reduction Grant Program Update

There were no public comments on item 4.

Ryan Wolfe, Manager of Sustainable and Resilient Development, shared that the Inflation Reduction Act (IRA) made historic investments in climate action and IRA investments would drive significant emissions reductions over the next decade. He stated EPA would play a major role in delivering programs and approximately \$41.5 billion in funding. He stated EPA's CPRG program objectives were to reduce climate and air pollution, support jobs and lower energy costs and address environmental justice. He indicated SCAG would lead agencies in each of the three metro areas on technical and engagement processes for Priority Climate Action Plans (PCAP's) and identification of competitive applications, help coordinate regional efforts with the state PCAP process and facilitate the Los Angeles and Orange County steering committee to develop the metro area PCAP and Comprehensive Action Plan (CCAP).

Members asked about collaborating with cities/counties and EV trucks.

5. Climate Adaptation and Mitigation Grant Opportunities

There were no public comments on item 5.

Sebastian Shetty, Associate Regional Planner, reported there were multiple climate-related grant opportunities that aligned with SCAG's mission to reduce greenhouse gas emissions and improve community resiliency to climate impacts. He stated those grants were sourced from the Inflation Reduction Act, Infrastructure Investment and Jobs Act, and the California State Budget. He provided a detailed overview of each grant source and included the amount of funding and application due dates.

6. Energy and Environment Committee Outlook and Future Agenda

Ryan Wolfe, Manager of Sustainable and Resilient Development, stated there would be six meetings of the Energy and Environment Committee during the fiscal year and there would be many items to cover, however SCAG staff would make accommodations as needed. He provided a brief update on the agenda items for fiscal year 2025 which included various topics and local resources.

7. Senate Bill 375 and Sustainable Communities Strategy Overview

Sarah Dominguez, Planning Supervisor, provided a brief history of the California Global Warming Solutions Act (AB 32) and discussed how AB 32 would be working with the transportation investments SCAG has made and how that will be reduce GHG emissions from passenger vehicles. She reported that since 2012 there were 500,000 new households located near transit and county transportation commission and local agencies had invested more in transit. She stated that since 2016, SCAG had been awarded \$75.9 million for local planning assistance and information services. She indicated that SCAG would work with the state and other partners to reach the goal of GHG reduction in the state.

CHAIR'S REPORT

Chair Plancarte reported that the 2024 Southern California Demographic Workshop would be held on September 24th from 9 a.m. to 3 p.m. at the SCAG offices in downtown Los Angeles. He stated the program would gather local leaders, elected officials, and demographic experts to discuss how changing population growth would affect regional planning. He reminded the committee there was no meeting for October and the next meeting would occur in November. Lastly, he welcomed Regional Council member, Patricia Lock Dawson, to the committee.

STAFF REPORT

Rachel Wagner, Government Affairs Officer, reminded the committee there would not be a meeting in October and thanked the committee members that attended the Port Hueneme Tour.

ANNOUNCEMENT

Member Ed Wilson stated he will not run for reelection and his last council meeting would occur on December 10th.

ADJOURNMENT

There being no further business, Chair Plancarte adjourned the Energy and Environment Committee meeting at 11:13 a.m.
